Scandals floor **Boris Johnson**

UK Prime Minister Boris Johnson announced his resignation as Conservative Party leader yesterday, bringing his scandal-plagued tenure to an end after less than three years.

Johnson was left with little choice but to step down after several high-profile members of his cabinet resigned in protest this week over his handling of misconduct allegations related to government officials. Dozens more members of his government have also quit.

Johnson was ultimately undone by his response to fallout from the resignation last Thursday of deputy chief whip Chris Pincher, amid allegations Pincher had groped two guests at a private dinner the night before. While he did

Speaking on independent television station 3Ktv's popular programme, Vantage, NPRC spokesperson Obert Gutu said the commission had a duty to help create peace and harmony in the country.

In this regard, he added, the commission had crafted a roadmap aimed at eliminating violence in the country, as well as promoting free and fair elections in 2023 - as captured in its 'Election Strategy' document.

This comes amid rising political tension and violence in the country, with Zanu PF and Citizens Coalition for Change (CCC)

HE Zimbabwe Electoral Commission (Zec) says it expects to complete the delimitation of constituencies and wards by December, way ahead of next year's general polls.

Delimitation is the process of dividing the country into 210 constituencies and wards for the purposes of elections. The process is carried out in terms of the country's Constitution.

pointed commissioners in Harare by President Emmerson Mnangagwa yesterday, the institution's chairperson Priscilla Chigumba said they were currently doing preliminary delimitation work and the coming in of the new commissioners would help speed up the process.

"As you know we must delimit final boundaries by December 2022, otherwise we can't use the new boundaries for the elections in 2023.

"Now that we are in the midst of our pre-delimitation processes, each of these commissioners (newly sworn in) will be sitting on multiand provinces where the issues surrounding delimitation will be discussed," Chigumba said.

"We are hoping to proceed with delimitation on a consensus building aspect where anybody who is not happy with the proposed boundaries will be at liberty to express their unhappiness in the multi-party liaison committees. That will help because local leadership, like chiefs and headmen, know their boundaries," she added.

not admit the allegations directly, Pincher said in a letter to Johnson last week that "last night I drank far too much" and "embarrassed myself and other people." Other historical allegations of misconduct by Pincher emerged in the ensuing days.

Johnson, pictured, initially denied being aware of some of those allegations, but ultimately the Prime Minister was forced to admit he had been briefed years before and apologize for his decisionmaking.

It was the final straw for many political allies who had supported Johnson through crisis after crisis over the years. In recent months the Prime Minister had been facing a barrage of criticism from all sides over his conduct and that of his government, including illegal, lockdown-breaking parties thrown in his Downing Street offices, for which he and others were fined.

Johnson faced numerous other scandals that hit his standing in the polls — despite his 80-seat landslide general election victory just two-and-a-half years ago. These include accusations of using donor money inappropriately to pay for a refurbishment of his Downing Street home and whipping lawmakers to protect a colleague who had breached lobbying rules.

With the possible exception of his hero, Winston Churchill, Johnson was perhaps the most famous politician to enter Downing Street as Prime Minister, having forged a successful career as a journalist, novelist, TV personality and London mayor in the preceding decades.

He was a populist before



moments of his time in office are images such as him inelegantly dangling from a zip wire or forcefully rugby tackling a 10-year-old child while on a trade visit to Tokyo. He just wasn't considered serious enough for the top job.

He was educated at Eton College, the most exclusive private school in the UK, alma mater of 20 Prime Ministers, followed by the University of Oxford. While at Oxford, he was a member of the notorious Bullingdon Club: An elite all-male group for wealthy students, famed for ostentatious (and sometimes rowdy) displays of wealth such as vandalizing restaurants, then paying for the damage on the spot in cash. Johnson was never proven to have been personally involved in any such activity.

Johnson worked as a journalist for establishment newspapers, most notably The Daily Telegraph, which made him its Brussels correspondent in 1989. It was in Belgium that Johnson began writing what would become the most important chapter of his life story: Brexit.

In 1999, Johnson was offered the editorship of The Spectator, a weekly magazine often jokingly called the "Conservative bible." He accepted, agreeing with the owner that he would drop his by now well-known political ambitions, according to a biography by political journalist Andrew Gimson. He kept his word for all of two years and stood to become a Member of Parliament in 2001. In the years that followed, Johnson was swallowed by the conservative establishment. He carried on writing the conservative script as a journalist and building a base of loyalists both inside and outside of politics. - CNN

youth recently engaging in running battles in Nyatsime - on the outskirts of Chitungwiza — following the gruesome murder of Moreblessing Ali.

"We have come up with an election strategy. This election strategy has been well thought-out and well researched.

"The election strategy speaks to issues of, for instance ... 2023 campaigns. So, the issue now is to say that we don't have to wait for there to be an incident of violence in Mbare or in Epworth or in Mufakose or in Makokoba for us to say what are we going to do.

"We have come up with a strategy that speaks to those areas where we feel that we can have a peaceful election," Gutu said.

"So the strategy is designed to say that we are a peace-building commission and as peace builders, what kind of strategy should we adopt to manage an election season ... how can we pre-empt violence?

"In most cases we are talking of physical violence ... This is where people as they campaign end up fighting, injuring each other, and in some cases even, unfortunately, killing each other or destroying property or doing anything that has the effect of disturbing the peace.

"We have that strategy that clearly states out the mechanisms that we are putting in place to deal with this," Gutu further told 3Ktv.

A former deputy minister of Justice during the 2009 to 2013 government of national unity (GNU), Gutu also said all political parties had to subscribe to a peace pledge and commit to shunning violence at all cost - before, during and after the 2023 elections.

country," Gutu said.

"So, this time we are working on a similar kind of pledge, but we would want to make it bigger and better.

"The whole commission is geared towards ... looking at a national peace pledge that should speak to the nation's desire to have peaceful elections.

"That should speak to the nation's desire to have elections where winners celebrate with respect and losers accept defeat with dignity," Gutu added.

"At the end of the day, we should appreciate as Zimbabweans that an election is exactly what it is, an election. There is going to be a winner and there is going to be a loser.

"The moment that we appreciate that we can actually have an election where there are losers and winners, but the aftermath of which is not violent, we will build a peaceful Zimbabwe," he also said.

"If you look at what I would call our mission statement as the NPRC, we are aiming at building a peaceful

Manchester United, but it doesn't mean that if they lose you have to declare war on Arsenal, which normally beats your team.

"I'm just using that as an example to say that we want a situation where people appreciate that an election is just a race, it's not a war. Haisi hondo," Gutu told 3Ktv.

"And the moment that we have that election strategy and also the national peace pledge speaking to that, I believe that the political players ... will appreciate that as the NPRC we are just there to ensure that politicians do their campaigning and do it peacefully.

"Do your activities and do them peacefully. When you go for elections, make sure the elections are peaceful and when the results are announced make sure the celebration is peaceful.

"You don't want to celebrate that you won and start saying very hurtful things to the person who would have lost the election, or you celebrate in such a way that instead of celebrating in peace you are creating conflict by maybe even resorting to physical violence as a way of celebrating.

populists really existed. His controversial comments — comparing Muslim women who wear face coverings to letterboxes, or calling gay men "bum boys" to name but two - appalled many. Yet, for all his ambition and charisma, the job of Prime Minister seemed out of reach for most of his adult life. Those who know Johnson personally say that he loathed the fact that many in the British Conservative elite saw him as a useful campaigning tool but more of a comedian cheerleader than a serious statesman.

Even during his time as Mayor of London, winning two terms in a city that traditionally doesn't vote

"As one of our key deliverables for this election season ... we are already working on what we call the peace pledge.

"This is the peace pledge that will actually apply to all the political players, particularly the political parties that intend to participate in the 2023 harmonised elections.

"If you remember in 2018 there was actually a national peace pledge that was signed by the majority of the parties, especially those parties that nominated presidential candidates in the 2018 harmonised elections.

"It was a grand occasion that was held, if I remember well, at the HICC (Harare International Conference Centre) and it was signed by most of the major political parties in this

Zimbabwe for all generations and the generation that is supposed to be doing that is this generation.

"We don't want a Zimbabwe that 25 years from now is on fire, three years from now is on fire. That's why we are talking of a peaceful Zimbabwe for all generations.

"It's important because we want in that election strategy to have particularly the political players to understand that it is just a contest," Gutu said further.

"It is not a situation where you say it's a do or die situation, where I have to win and if I don't win then there will be war.

"We should appreciate that it's just like football. I know you support that team that has been losing all the time,

"You want to celebrate, like I said, with dignity. Even the person who would have lost should also be able to concede defeat with dignity," Gutu also noted.

"These are some of the issues that we think the national peace pledge will speak to. To say this is our country.

"It doesn't matter whether you are a member of Party A, Party B or Party C, or Party X or Party Y or Party Z. We are all Zimbabweans.

"When we win we are winning together and when we lose we are losing together," Gutu further told 3Ktv.

ARLIAMENTARIANS Job Sikhala and Godfrey Sithole, accused of fanning violence in Nyatsime, Chitungwiza, suffered another setback yesterday after the High Court dismissed their bail appeal.

The two were denied bail by deputy chief magistrate Gibson Mandaza and took the matter to the upper court challenging his decision.

However, Justice Lucy Mungwari upheld the magistrate's decision, ruling there was no error in Mandaza adjudging that the two were likely to commit further offences.

"The first accused (Sikhala) is said to have voluntarily told the court aquo that he has been arrested countless times, he also

violated his bail conditions from another matter that is before the courts, which prohibits him from addressing any public gatherings or involve himself in any acts of violence.

"This shows that the first accused has a high propensity in committing a similar offence while on bail," ruled Mungwari.

Sikhala is alleged to have posted a video on social media allegedly inciting people to commit violence and avenge the death of one Moreblessing Ali who was murdered and her remains were found in a well.

Justice Mungwari stated that the alleged sentiments by Sikhala "revealed so much violence and seemed like a genuine attempt to raise anarchy".

The judge said the release of the two is likely to "disturb the peace and safety of

and Jeremiah Bamu, the two said the lower court had misdirected itself in applying the law when it found that Sikhala had a high propensity of committing crimes as he has not been convicted on any of the allegations that he is facing.

The lawyers further argued that the State had no case against Sithole but had just roped him in to satisfy the requirements of the crime to just join him with Sikhala.

The two were yesterday remanded to August 2 after regional magistrate Stanford Mambanje declined their application challenging further remand.

The two have also indicated that they will be approaching the court for another bail application, this time on changed circumstances.

Harare City footballer in drug storm

HARARE City footballer Jerry Chipangura has been nabbed on allegations of dealing in crystal meth after he was allegedly found with two sachets in his bag.

He was not asked to plead to the allegations when he appeared before regional magistrate Stanford Mambanje yesterday.

He was denied bail and remanded in custody to August 4. It is the State's case that on June 30 at around 8pm, the police received information that Chipangura was dealing in meth in Mabvuku.

Acting on the information, detectives went to the place and found him along John Tapedza Road, Old Mabvuku, before identifying themselves and informed him of their visit.

The police reportedly searched his small bag and found two sachets of meth, resulting in his arrest. They went to his place for further searches, but nothing was found. The court heard that a preliminary field test was conducted and it tested positive to meth, weighing 40 grammes with a street value of \$200 000.

Meanwhile, a Harare family found itself before the court on allegations of unlawful possession of meth.

Bobby Nyazvigo and his wife Charity Makanda and their 17-year-old daughter were all nabbed and brought to court.

The court heard that the police got information that they were in possession of the drugs at their home in Dzivaresekwa. When they got there, it is alleged that they searched the suspects and found seven sachets of crystal meth in Makanda's jacket pocket.

It is alleged that the detectives also found one sachet of crystal meth in Nyazvigo's trousers pocket and they allegedly found six sachets of the drugs from their daughter's jacket pocket weighing 12 grammes, resulting in their arrest. The court heard that a preliminary field test was conducted and it tested positive to meth.

Their daughter was only freed after evidence was produced to show that she was still underage, leaving her parents in custody and fighting for bail.

HE Bulawayo City Council (BCC) has indicated that it is working on rolling out awareness campaigns in the city to conscientise residents about the deadly monkey pox disease.

While, Zimbabwe is yet to record a single case since the disease was detected in the United Kindom in May, the authorities have remained on high alert to ensure it doesn't spread in the country.

Speaking to the Daily News yesterday, Bulawayo Provincial Medical director Maphios Siyamuchembu confirmed that they were ready for any possible outbreak.

"We know the disease has been detected in South Africa but we don't have any case here, but as authorities we remain on high alert," he said.

BCC however, said it was working on educating the residents on the dangers of the disease.

According to the latest

council's report of the Health and Housing Education Committee, councillor Shadreck Sibanda raised concerns about the increasing cases of monkeypox globally and wanted to know if the local authority's readiness.

In response, councillor Snikiwe Mutanda said "health campaigns would be done accordingly with regards to monkeypox."

Meanwhile, BCC health director Edwin Sibanda said the health emergence response team was on high alert.

"As soon as there was an announcement that monkeypox has been detected, our emergence and preparedness response team went into action and is ready for monkeypox, fortunately evidence available shows that it is not as lethal as initially feared but it doesn't mean that it doesn't exist. Our team is active and alert," Sibanda told Daily News yesterday.

This comes after government recently noted that the Risk Communication Sub-Committee must immediately embark on a monkey pox information dissemination as part of measures to prepare for the disease in case it's detected in the country.

The government also said they have put in place surveillance, laboratory testing, and case management measures.

Monkeypox is a viral zoonosis transmitted from animals to humans that produces symptoms similar to those observed in smallpox patients in the past, although clinically less severe.

As of July 2, 2022, there were 6 178 confirmed cases of monkeypox worldwide. The nation with the highest number of cases is again the UK where a total of 1 236 cases were detected. In second place among the nations with the most Monkeypox cases on July 2 is Spain with 1 196 cases and Germany with 1 054.



Road rehabilitation stalls in Byo

THE much-publicised Emergency Road Rehabilitation Programme 2 (ERRP2) meant to restore normalcy on the city's largely damaged roads has stalled owing to a logistical and financial crisis.

The development, according to the latest council report has seen some contracted companies pulling out, in the process affecting the progress of the programme.

"The city continued with 2021 ongoing priority projects as part of the 2022 road rehabilitation programme under the 2022 budget. All works were currently on hold either due to delayed payment or application for increased costs," reads the report.

In an update to the city fathers, town clerk Christopher Dube cited a number of reasons why the programme has been put on hold.

"The programme was supposed to have been completed by the end of last year (2021) however, progress had been hindered by challenges which were beyond council's control. Contractors had delayed going on site resulting in price increases on materials.

Others had pulled out of their contracts citing delays in payments. Some suppliers had also demanded upfront payment for their services. Fluctuation of the local currency and lack of fuel in local currency also stalled progress," Dube said.

This however, comes at a time government last month took a swipe at the Bulawayo City Council (BCC) for failing to utilise the funds availed for road rehabilitation in the city. This was after it had emerged that the local authority had only utilised 10 percent of the allocated funds.

However, in the latest report, the town clerk defended the local authority's failure to utilize the funds.

"The town clerk confirmed that part of the funds which were allocated to council were not utilised because of challenges experienced. Council could not spend the money because of procurement issues. Contractors had expected an advance payment but Zinara had advised that there was no advance payment.

"The contracts awarded were never completed and the council could not produce a certificate of payment. It was on this background that the council decided to defer the projects. Council was advised to rescind its decision that deferred the programme because the roads rehabilitation programme was a government programme and council was only an implementing agent," the report said.

The city was last year allocated more than \$625 million for the rehabilitation of its estimated road network covering 2 460km. Government released \$217 million and the rest of the funds were expected to be disbursed after initial acquittals had been made, but council only used \$21 million of that amount.

BCC is on record saying that 70 percent of its road network has outlived its lifespan hence it requires about US\$700 million to fix the roads.

Delta crowned Top Company for 2021

IMBABWE Stock Exchange (ZSE)-listed beverage maker, Delta Corporation, was last night crowned the best performing company on the local bourse for last year at the Financial Gazette's Top Companies Survey 2022 spon-

sored by financial services giant, Old Mutual Zimbabwe.

Mobile network operator Econet Wireless and Simbisa Brands were named the first and second runnersup respectively.

"Delta comes out supreme in the 2022 Top Company survey following a similarly rigorous exercise of quantitative and qualitative evalua-

tion factors.

Whilst Delta may not have come out tops in each of the evaluation factors, it did score consistently high in both the qualitative and quantitative factors in this years' survey of deserving Top Companies.

"The complexities of the Zimbabwean environment when it comes to assessing the financial performance of listed companies made the task equally more cumbersome in this year's edition of the Top Company Survey," Top Companies Survey 2022 judges' chairperson Simbiso Musa said.

Delta also won the Disclosure and Investor Relations award after scoring a fair balance in the transparency of its financial statements. "It did

this by being bold enough to recognize significant auditor oversights when comparing the substance of actual business reality versus what is legally and technically compliant in the reporting

of its financial performance. "The

qualitative attributes of the company in fairly disclosing the strides made in expanding into the region through the acquisition of major players in the opaque (sorghum) beer markets in Zambia and South Africa started to reflect on the company's financial statements and shine a good light on leadership aspects of the survey," Musa added.

Ecobank Zimbabwe was also named Top Banking Institution 2021, Nicoz Diamond also got the Top Insurer (short-term) accolade while Doves Life Assurance took the Top Life Insurer gong.

The Best tangible Investor Returns Award went to Simbisa Brands, while the Special Mention Award was taken by TelOne and Hippo Valley Estates snapped up the Most Improved Disclosure and Investor Relations Award.

The 2022 Top Companies Survey 2022 ran under the theme "Innovating for growth in a VUCA environment". This largely sums up the operating environment in Zimbabwe, which is very volatile, unclear, complicated, and ambiguous

For this year's survey, Musa said it was clear that the local market was still struggling with timely publication of results, which, on the other hand, is a critical component of creating efficient markets.

"We continue to have more than 90 percent of our listed companies missing the regulatory deadlines and most financials carrying qualified opinions. Our challenge to the accounting bodies is to protect the market's reputation by changing the current status quo and strive to raise our standards," Musa further said.

RBZ rubbishes coins rumour

THE Reserve Bank of Zimbabwe yesterday dismissed as "fake news", social media reports alleging that gold coins are already available ahead of their official release date.

The central bank announced on Monday this week that the coins would be available for purchase starting July 25. In one incident, a man is seen holding gold coins of unknown origin or authenticity, which was widely circulated on social media.

But, the RBZ said the coins were yet to be released. "Videos and messages circulating on social media purporting or giving out that gold coins are available for sale and that some people already have them are nothing, but fake news," the central bank said.

"For the record, RBZ has not released any gold coins and the gold coins will become available on 25 July 2022 as earlier advised by RBZ."

The coins, being introduced as an alternative store of value and also as a way of propping the local currency, will be sold to the public in both local and foreign currency at a price based on the prevailing international gold price and production costs. They will be sold through the RBZ and its subsidiaries, Fidelity Gold Refinery and Aurex, local banks and selected international banking partners.

OVERNMENT has called for a crucial meeting with civil servants on Monday to address the welfare of its workers amid an imminent industrial action.

This comes after public sector workers gave the government a two-week ultimatum to address their salary demands or they embark on a strike.

Speaking to the Daily News yesterday, the Public Service minister Paul Mavima, pictured, said the government was ready to consult with civil servants to reach common ground.

'We are in a negotiation process and we have not yet reached a stalemate. The National Negotiation Joint Committee (NNJC) met and

Zim should do more to finance agric insurance

ZIMBABWE must do more to finance agriculture insurance as climate change is now heavily affecting the sector, African Risk Capacity Limited (ARC) chief executive officer Lesley Ndlovu has said.

Speaking to the Daily News yesterday, Ndlovu said the government should be always prepared to deal with the effects of climate change.

"Throughout Africa we are having a concentration of droughts, in Eastern Africa and Southern Africa. It is incumbent upon businesses and government to ensure that they take out the necessary insurance policies against these events such that when they occur, the disruption to livelihoods and business is minimised as much as possible.

"Zimbabwe needs to be more prepared for disasters and financing mechanisms need to be set up in advance and well-oiled so that we are prepared to deal with them.

"When you look at the economy of Zimbabwe, agriculture is one of the main contributors to the GDP, therefore, if we suffer drought in Zimbabwe it means it will be negatively impacted and as a result we need to protect investments in agriculture," he said.

The country's agriculture industry last year grew to US\$7,89 billion and the authorities are targeting to grow the sector to US\$10 billion by 2025.

"The worth of the agriculture sector, and roughly one percent of that on insurance is enough for the size of the agriculture market.

"The government of Zimbabwe is one of our clients and partners within the ARC and we paid a claim of US\$2,4 million after the 2019 drought, since that we have been very active in Southern Africa.

"What we have seen in Zimbabwe through schemes such as Pfumvudza is where the government itself is playing an aggregation role in including insurance in the financing of agricultural inputs. That is one way of increasing insurance penetration, ensuring that the people who need coverage ultimately get it," Ndlovu said. ARC is a mutual insurer of the African Risk Capacity Group which is an agency of the African Union, its mandate is to assist member states to improve the resilience of their populations in the face of climate change.

"Be advised that the industrial action hereby notified is in respect of a long overdue cost of living adjustment that speaks to the food basket that now stands at \$114 000, against the latest adjustment to \$36 000 for the lowest paid worker

"We, the undersigned federations hereby advise accordingly," the unions said in their communication to Mavhima.

The ultimatum comes hard on the heels of a recent strike by health services workers who were demanding a salary hike and improved working conditions.

It also comes after the government recently hiked salaries for its workers by 100 percent, in addition to unveiling a housing scheme and access to free importation of motor vehicles for their use.

However, the Zimbabwe Confederation of Public Sector Trade Unions (ZCPSTU) has flatly rejected the offered package, insisting that this was the same offer dismissed at the National Joint Negotiation Committee (NJNC) meeting of June 17.

A lot of criminals have been electrocuted, but more and more people continue to vandalise electricity infrastructure at the expense of ordinary people, industry and commerce.

The country should have zero tolerance to vandalism of any infrastructure. The law should be seen to be taking its course regardless.

What is worrying is that some of the employees at public utilities are on the forefront of vandalism.

Media reports abound of public utilities employees stealing cables and sabotaging transformers for their own personal benefits. That has to be brought to a screeching halt. Their nefarious activities are tantamount to sabotage and must be nipped in the bud!



Beyoncé 'is running MeToo checks' on potential collaborators


B EYONCÉ, pictured, has reportedly "run #MeToo checks" on potential collaborators. The *Break My Heart* hitmaker is said to have vetted artists and producers for her upcoming album *Renais*sance and rejected anyone who has faced allegations of harassment or abuse.

An insider told *The Sun* newspaper's Bizarre column: "Her team now runs #Me-Too checks on any potential collaborators. Two songs from high-profile artists have been rejected because of allegations they are facing.

"Although neither has been found guilty, she's sending a clear message to the industry in the wake of troubling cases from people like R Kelly and Harvey Weinstein."

It's said the 40-year-old star "wants to set an example", and she "doesn't care" how people react to her decision.

The source added: "She's



rubbed some people up the wrong way but she doesn't care. She won't go anywhere near you if you've been accused of going after one of her peers.

"Beyoncé is a leader in her business and wants to set an example that any abuse shouldn't be normalised.

"This is why her new record is about empowering women."

The report comes after Beyoncé recently revealed she wants to "create a safe space" through the music on her upcoming album, as well as a project "free of perfectionism and overthinking".

She wrote: "Creating this album allowed me a place to dream and to find escape during a scary time for the world.

"It allowed me to feel free and adventurous in a time when little else was moving.

"My intention was to create a safe place, a place without judgement. A place to be free of perfectionism and over thinking.

A place to scream, release, feel freedom.

"It was a beautiful journey of exploration."

So far, Beyoncé has unveiled lead single *Break My Soul*, a house track that samples Robin S hit *Show Me Love* and Big Freedia's *Explode*.

She added: "I hope you find joy in this music. I hope it inspires you to release the wiggle. Ha! And to feel as unique, strong, and sexy as you are." — IOL

Rihanna is now the youngest female self-made billionaire

AT 34, RIHANNA is the youngest person on *Forbes*' 2022 list of self-made female billionaires in the United States. Find out where Kylie Jenner, who held that title in 2019, now stands.

As it turns out, Rihanna does have her money.

The 34-year-old is now the youngest self-made female billionaire in the United States after amassing a net worth of \$1,4 billion, according to *Forbes*' 2022 list. Her impressive milestone comes more than three years after the outlet bestowed the much-coveted title to Kylie Jenner, who is estimated to have a current net worth of \$600 million.

According to *Forbes*, Rihanna — as co-owner of Fenty Beauty and holder of 30 percent stake in her Savage x Fenty lingerie line — is also her native Barbados' first billionaire, as well as the only woman under 40 on this year's list of female billionaires in the US.

Her net worth may soon go up, too. The singer, who recently welcomed her first child with A\$AP Rocky, has been teasing that she has new music in the works.

"I'm looking at my next project completely differently from the way I had wanted to put it out before. I think this way suits me better, a lot better," she told *Vogue*. "It's authentic, it'll be fun for me, and it takes a lot of the pressure off."

However, that doesn't mean Kylie's fortune isn't just as impressive. As the

Forbes notes, the 24-year-old Kardashians star is still the youngest member on its list of America's richest self-made women, which also consists of Taylor Swift (\$570 million) and Bumble founder Whitney Wolfe Herd (\$740 million). The ranking marks Kylie's fifth consecutive year on the list.

Back in March 2019, Kylie held the title of youngest self-made billionaire after signing a distribution deal with beauty retailer Ulta for Kylie Cosmetics products, which were then only available online or at pop-up shops, to be sold at their locations. At the time, *Forbes* reported that the strategic move helped edge Kylie Cosmetics' estimated worth to "at least" \$900 million, making its founder a billionaire.


The Kylie Cosmetics mogul saw more money signs in November 2019 when she agreed to sell 51 percent of the beauty brand to Coty Inc. for \$600 million. The deal valued her business at about \$1,2 billion.

But in May 2020, *Forbes* published an article saying that their staff "recalculated Kylie's net worth and concluded that she is not a billionaire," but rather a "more realistic accounting of her personal fortune puts it at just under \$900 million."

Still, Kylie wasn't fazed with her title being revoked and said, "I can name a list of 100 things more important right now than fixating on how much money I have." — eonline.





ABLES technical manager Godwin Murambiwa chose to dwell on the positives after Zimbabwe's quest to qualify for the 2022 Rugby World Cup came to a screeching halt Wednesday night at the Stade Maurice David in France.

'There are some people who were trying to stop that particular meeting but it was never stopped. We went there (to Cosafa) and had a very fruitful meeting."

The interim Zifa board is expected to meet another former association president Cuthbert Dube next week.

Zifa turn to Chiyangwa in Fifa engagement

HE Zimbabwe Football Association (Zifa) has engaged former association president Philip Chiyangwa to use his influence in initiating talks with the world football governing body Fifa for the country to be readmitted into international football.

Chiyangwa, who recently stepped down as Cosafa president, and a well-known confidante of Fifa leader Gianni Infantino, has already facilitated a meeting between interim Zifa boss Gift Banda and regional leader Artur de Almeida a fortnight ago in South Africa to kick-start the process.

This comes after Zimbabwe were suspended by Fifa in February this year owing to "undue interference by a third party".

This was after the Sports and Recreation Commission (SRC) suspended the Felton Kamambo-led board in November last year over "several incidents of gross incompetence" that they described as "contrary to national interest."

The development saw Zimbabwe being booted out of the 2023 Afcon qualifiers as well as the Cosafa Cup which is currently underway in South Africa.

The SRC has since reinstated the Zifa board but Zimbabwe remain suspended as they are awaiting Fifa's endorsement after Zifa president Kamambo, Philemon Machana and Brighton Malandule were frozen out at the association's EGM on April 23.

Fifa are expected to issue their position any time after they acknowledged communication from Banda's board which is made up of other members, who were part of Kamambo board.

Yesterday Banda confirmed Chiyangwa's involvement in their efforts for Zimbabwe to be readmitted into international football after paying a courtesy call to the former association president in the capital. Banda was accompanied by Zifa board members Farai Jere and Alois Masepe who was recently co-opted into the executive committee as well as the association's chief operations officer Xolisani Gwesela "As they always say, if you recognise your ancestors your job becomes very easier. It was the man seated next to me here (Chiyangwa) who when I got into this office, we all know how Chiyangwa is and he asked me urikunvatsode chii iwe (what exactly do you want from me)? "I told him Bhora ririkunetsa mukoma (it's not looking good in our football) and he picked up the phone that's how it all started, him organising a meeting for us and we went to South Africa. >>>P19
